Water usage gal/mo: April 407,700-May 476,200 (leak @ 182 Broadway=85,630gals)

<u>Water System Changes:</u> moved pit @ 48 Linden Dr, 57 Mae Ln new meter(#114), setter, pit. Needs padlock due to capped water line on owner side, not reconnected due to galvanized line failure.

- * Shut off tube ran over at 297 3rd St, is on Village's side of meter, this will need repaired.

New Business:

An Ordinance Amending Zoning: Bill#102-23 of the Village of Coney Island Village code pertaining to zoning including articles I-VII. For the properties located within the Village of Coney Island, MO. - 1st reading and discussion pros & cons setback and % coverage. Darren motions to remove % coverage, and to change the setbacks for all types of districts: Front 15′, abutting 15′.(side interior stays 5′ and rear stays 10′. Dave 2nd. All in favor. CC district parcels:14-6.0-23-003.000 and 6.0-23-003-001-003.001. LDR designated in yellow. 2nd reading and Roll call vote: Darren aye. David aye. Jennifer aye. John aye. Abstain none. This Bill 102-2023 was declared passed and sent to the chairman for signature. This Bill thus becomes Ordinance #22-2023. Dave motion to sign SMCOG contract for
